Some of the main components of this new program are highlighted below

- 1. As directed by the Centers for Disease Control (CDC), Juniper uses EPA approved chemicals that kill 99.9% of all bacteria and viruses on all surfaces.
- 2. "High-Touch" area disinfection on a frequent, routine basis. These areas include, but are not limited to doors, door knobs, handrails, elevator buttons, entryway keypads, community telephones, light fixtures, light switches, etc.
- 3. Detailed resident apartment cleaning and disinfecting including but not limited to doors, door knobs, fixture switches, light switches, hard surfaces
- **4.** Routine disinfection for common areas and resident apartments as a disinfecting solution (Puroxcide) that meets the EPA criteria for use against COVID-19.
 - **5.** Hand sanitizer available at high traffic areas throughout the community.
 - **6.** All associates trained and required to wear approved Personal
 - **7.** All associates monitored / screened on a daily basis for symptoms
 - **8.** All visitors are screened on a daily basis for symptoms including temperature and required attestations.
 - 9. Each community has a Juniper certified plan to construct a CDC
- **10.** All new residents and returning residents are required to undergo COVID-19 testing prior to admission, as well as a post move-in test 48 hours
- 11. All new associates are required to undergo COVID-19 testing prior to
